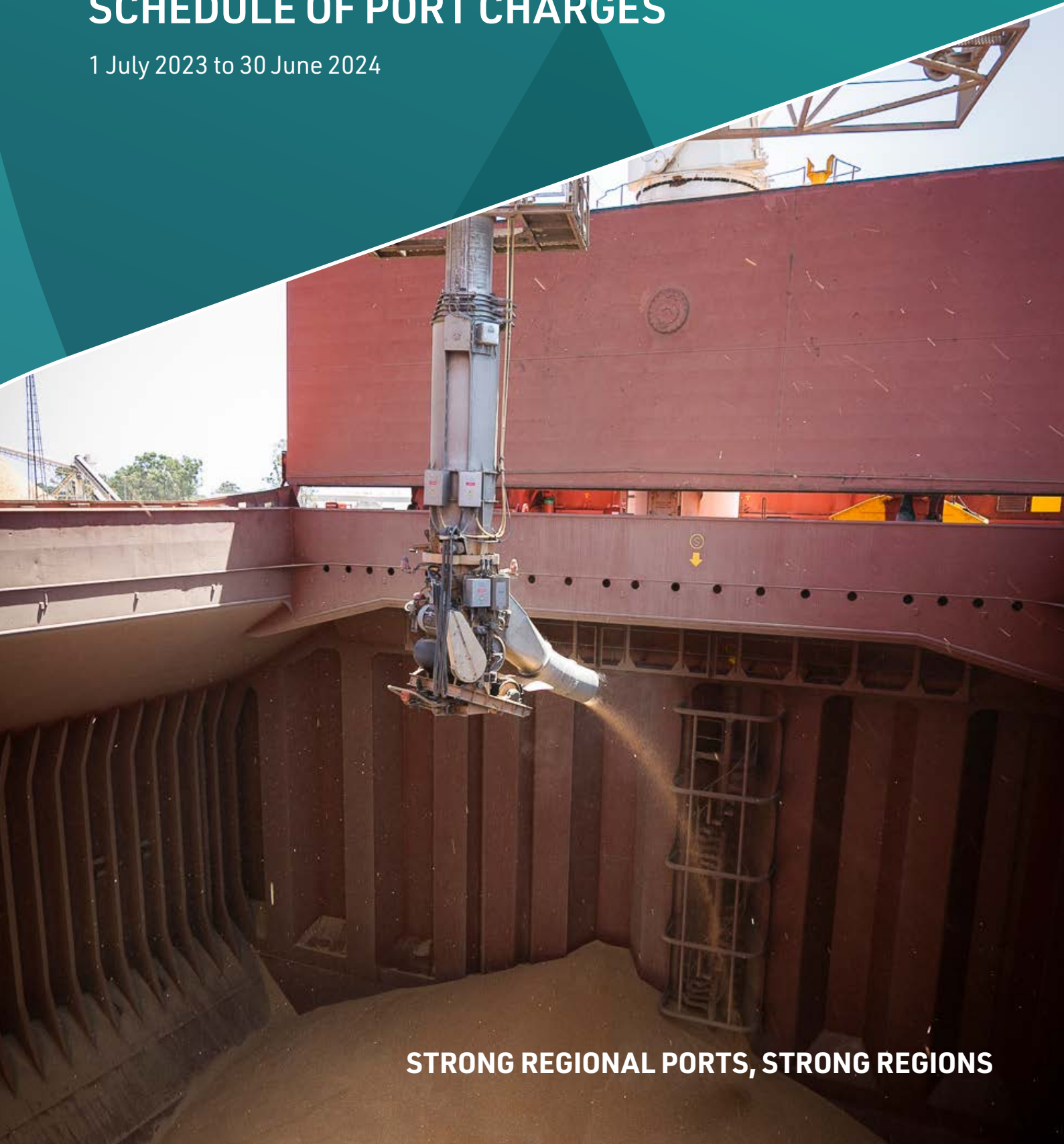

SOUTHERN PORTS PAYMENT TERMS

Pursuant to the *Port Authorities Act 1999* (WA) (the Port Act), charges payable in relation to a vessel are payable (jointly and severally) by the owner, master and agent of the vessel and each person who is a consignee, consignor or shipper of goods on the vessel. Charges payable in relation to goods (cargo) are payable (jointly and severally) by the owner, consignor, consignee or shipper of the goods and each agent for the sale of or custody of the goods or each person entitled to possession of the goods and the owner of the vessel on which the goods were carried.

Southern Ports may elect (in its absolute discretion) to extend credit for the payment of charges for up to 30 days. However, all charges shall be payable upon the relevant vessel berthing at the Port of Albany, Port of Bunbury or Port of Esperance (as the case may be). Interest at the rate prescribed under the Port Act will be levied on all amounts outstanding after the due date for payment as stated on Southern Ports' tax invoice. For convenience, Southern Ports will invoice the agent of the vessel for vessel charges, however Southern Ports reserves its right to recover payment from those persons liable for vessel charges under the Port Act.
